- (D) Phase 5 Desert-scape Project: Rafael stated we have received approval for our rebate from DWA at \$4.00 per square foot of grass removal. We received a quote from O'Connell Landscape for \$121,036.00 for Phase 5, minus the rebate, the cost will be around \$46,000. Judy made a motion to accept this bid. Lori seconded. Motion approved.
- **(E) Turf Conversion**: We received 3 bids for the turf conversion at Pool 1. We will remove 800 Sq Ft of grass receiving a \$4.00 rebate at approximately \$3200.00. Steve made a motion to accept the bid from Center Stage Turf Inc. for \$7940.94. Smitty seconded. Motion approved.
